Minutes of Pre-Bid Meeting for Hiring services of CDM Consultant for Yunus Energy Ltd. Held on 16th March 2012

The pre-bid meeting was held on 16th March 2012 in AEDB Head office Islamabad to respond to the queries of the bidding companies against the RFP issued for hiring services of CDM consultant for Yunus Energy Limited (YEL) project. The queries raised and their responses are given below:

1. Bid Bond

The bidders proposed to not to take bid bond as it would not be possible for them to form any basis to determine 2% of the bid value when actual numbers of the CERs and future prices of CERs are unknown at time of submission of proposals. Further, the RFP requires posting of Performance Guarantee of USD 5,000/- by the selected consultant. In presence of this security, the obligation of submission of bid bond may be lifted. The client i.e YEL and CPPA agreed to the suggestion.

Decision:

The bidder will not be required to submit the bid security along with the proposal. However, they will submit the Performance Security as per the terms of the RFP that would remain valid till the signing of ERPA. Afterwards, the terms of the ERPA will govern.

2. <u>Clause 12 "Consultant Not to be Engaged in Certain Activities" of the Draft</u> Contract Attached to the RFP:

The bidders highlighted that the this clause of the draft agreement will restrict the selected consultant to carry out any other consultancy services in this sector. They therefore restricted that the clause may be deleted. The client i.e. YEL and CPPA agreed to the suggestion.

Decision:

The clause 12 of the draft contract will not be applicable any more.

3. Third Part Consultation Fee:

The bidders seek clarifications that who will bear the third party cost of validation for the DOF

It was clarified that the TORs have already stated that the cost will be borne by the selected consultant.

4. Contract Options:

M/s Yunus Energy Limited initially proposed to keep the option open for the bidders to either bid for ERPA signing or sign a separate consultancy agreement. It was pointed out that by keeping bother options available, this would be very difficult to evaluate the bids under one uniform criterion. This would lead to complexities as well.

Decision

It was decided that the bids will be called for signing ERPA only.

5. Bid Evaluation Criteria:

The participants suggested that bid evaluation criteria may be developed and uploaded on the website upfront.

Accordingly, it was decided that the technical bids will be evaluated as per criteria given in Annex-I to this document. The financial bids will be evaluated on price of ERPA. The bidders will be required to include all other costs in the cost of CERs. The criteria for financial bid evaluation is given in Annex-II.

6. Technical Bids Opening Date:

It was decided that the bidders will be given appropriate time to submit the bids after the clarification issued in pursuant to the PPRA Rules. Accordingly, it is decided the final date for submission of bids is Friday 30th March 2012 till 1000 hrs. The technical bids will be opened on 30th March 2012 at 1100 hrs. The financial bids of the successful bidders would be opened as per decision of the JMC.

All the JMC members would be required to be present during the opening of technical and financial bids.

7. The meeting ended with vote of thanks to all.
